2 The use of the Web Site

- 2.1 All persons NOT adults can not in any way appear in webcam.
- 2.2 There can be no people that have not been given the identity document or video in the same room.
- 2.3 You can not show her breasts or private parts unless you are in private chat or have received a TIPS to show you in Free Chat.
- 2.4 It 'FORBIDDEN show in webcam if the model is pregnant.
- 2.5 are PROHIBITED forms of incest (sexual relations with members of the family), simulation or other acts of a similar nature.
- 2.6 E 'FORBIDDEN defecate (scat), pissing , vomiting or simulated.
- 2.7 No form of SLAVERY 'will be permitted. (Example: If there are more people in front of the webcam, nothing will be handcuffed or tied together).
- 2.8 NO form of self-mutilation will be allowed.
- 2.9 E 'forbidden any exchange of social network account, email, instant messaging, telephone number, physical address during and after discussing with the clients (example: Google, MSN, Facebook, Twitter, Skype, Yahoo!, etc.)..
- 2.10 The Prostitution is strictly PROHIBITED, as well as DRUGS and illicit drugs.
- 2.11 The absence in front of the webcam should not exceed 1 minute.
- 2.12 The presence of pets in the video in a sexual or provocative is strictly prohibited.
- 2.13 Illegal activities of any kind or dangerous, violence, blood, torture, pain, erotic asphyxiation, or any action to create you a damage of any kind are prohibited.
- 2.14 Models are NOT allowed to advertise other commercial websites that offer live webcam transmissions, under any circumstances by PUNTOCAMS.
- 2.15 Models are NOT allowed to ask for your account information to other members or use access credentials that do not hold to access the site.
- 2.16 The models that seek to deceive members transmitting previously recorded video instead of actually being live on webcam will be immediately excluded from the site, without receiving any payment.
- 2.17 Any attempt at fraud will result in a permanent ban of access, without receiving any payment (such as complicity with a customer or "hacker" accept private shows paid for with stolen credit cards). Models are required to report each these suspicious activities, and the template itself can be regarded as an accomplice.
- 2.18 If a model promises something in return for TIPS, has a duty to follow the promise. The models that intentionally try to defraud members will be penalized or removed from the site.

4.Terms payment

Each month is divided into two pay periods: the first period is from the 1st to the 15th day of the month (inclusive), the second from 16 to the last day of the month (inclusive) PUNTOCAMS make every effort to pay within 7 working days the end of each pay period (usually 1-2 days), and no later than within 28 days of the end of each pay period, if the balance is greater than the minimum required for the chosen payment method.
